Please give a description of what you want this grant for - (please limit your answer to 500 words or less)

We would like the funding to offer 2 fun days over the summer holidays, both being held in the West End Campus, as it is the largest hall space in the ward and sits on the border between the south and north portion of the ward, so accessible to families throughout the ward.

These events will bring together local people and agencies and organisation to provide information to families. This event will be inclusive as there will be no costs as a barrier and a free lunch will be provided by Dundee Bairns. The current cost of living crisis is a difficult time for most families and it is important to have events where organisations can engage with local families and families are aware of support out there and help they may be entitled to especially during this difficult time.

Which City Plan / Local Community Plan Outcome(s) will it address?

We need to respond to the cost of living. As a result of the current CoL crisis, it is important more than ever to make sure that we provide no cost activities for families in the West End. Local engagement with families in the area suggested that out with school, there was no spaces for families/children to interact. We have invited information services that can look to support families during this time such as welfare rights/social security Scotland/ Energy Advice and the community fridge to promote the fridge as well as services providing activities.

We need to improve local supports for people in recovery and their families: Open event for all to attend.

We need to improve life chances for children and families

As aforementioned, we will be inviting services to ensure benefit maximisation/benefit support and entitlement for families. No cost activities and free lunches provided by Dundee Bairns. It is also a family event, so parents will be trying activities with their children.

We need community facilities in the West End – As mentioned we do not have a community centre in the West End so have to use building such as schools etc

to provide space to put on events/engage with the community. There is a lack of spaces for people to seek information/or a base to liaise with the communities team, so having events like this help people/families engage with these agencies and more knowledgeable about the support/help available.

These events are needed as highlighted throughout the application due to the lack of community facilities in the West End ward. We are also aware of the effects of the cost of living on parents and is not only an opportunity to engage with families, provide an event that has no cost, but also an opportunity to approach support services that do no base in the area due to lack of facilities to do so on a regular basis. Although some families may be aware of some services. The current crisis is effecting more people than ever, so this even being more open than target to small numbers means that anyone can come along and perhaps a starting point for this with no knowledge of support at all.

What local consultation has taken place regarding this application?

We have recently engaged with families with regards to the local community plans. It was identified that there is no out of school/local events for families. Activities can be private and costly. It was noted no community centre, so no provision similar to other areas in the city.

There was support for fun days and other events throughout the summer/year.

Publicity will be targeted within the community to School and Family Development Workers, churches, libraries etc so families that are aware of the activity and as no cost, will be no barrier to participate. We know from working with SFDW's that there are more families asking for support, but aware there are

more families in the wider community that are struggling that have not accessed services yet as unaware and struggling, so an event like this would provide a space to access that information and gives the children something to do during the school holidays which will be challenging for most families due to current costs and an extended period of time to spend money on food etc out with normal school day costs.
