- The Physical & Environmental Improvement Fund is to provide financial assistance for community initiatives aimed at improving the local area through Capital expenditure. Coldside Ward is a very built up ward and the Hilltown Park is one of the few accessible spaces in the Ward. This park is central to the Ward and therefore within easy distance of the majority of local residents. The Park is surrounded by predominantly blocks of flats. This is also central to some of the most deprived areas in Coldside, being able to provide some activities including a picnic at the start of the holidays will help bring families together with organisations and create a fun atmosphere for engagement and activities.
