The closest defibrillator to the Crescent is at least a 5 minute walk, here at the Newfield practice we have recognised this and have a doctor trained to facilitate basic life support training. To allow this to happen most efficiently, we are looking to purchase manikins (adult and child) and a replica defibrillator. This training will be offered to all volunteers at the practice but also looking to do a number of training sessions for the local community to ensure that they are fully trained to deal with any life threatening situation. In the first instance, this would be once a quarter depending

on demand and the priorities of the practice. We also have a coordinator trained in facilitating Naloxone training which we would offer alongside this.

Recently, the Newfield Community Group was set up. This charity will focus directly on the advancement and support of improving health in a local population of Dundee in one of the most deprived addresses in Scotland by working closely in association with a GP Practice. Although, This is not restricted to those registered with the GP practice. The aim of the charity is to bring together community groups and local people so they have a place to support, learn and grow.

#### Which City Plan / Local Community Plan Outcome(s) will it address?

This will address one of the visions in the city plan. This is, "be a caring city which has tackled the root causes of poverty and delivered fairness in incomes, education and health" and additionally elements of "Dundee will be a greener city, made up of strong communities where people feel empowered, safe and proud to live." As this will make sure that the community in which we work will be safer and individuals will feel empowered to keep this safe.

With regards to the Locality Community Plan this will address the health and wellbeing aspects of "We need to improve life chances for children and families." This will allow more individuals in the area to gain these life saving skills.

This is needed to allow individuals and families to have the skills to save a life if needed. As much as there are defibrillators in the area, the closest one to the crescent is at a five minute walk away. When someone is in cardiac arrest, time is critical and being able to give effective CPR increases the chances of survival.

Speaking to our current volunteers, this type of training is something they have expressed interest in and also something that would be valuable as if they are volunteering in the cafe space there will not be a medical professional present at all times so all volunteers being trained in this would help save a life, if any medical emergency was to arise.
