Logie Complex has had a small arts and garden project running since late 2022. This has involved workshops delivered by Community Artist Pam Bennett.

Tenants have enjoyed visits to Dundee Botanic Gardens and have produced decorative items to improve the complex garden attached to the community lounge.

The garden was looking tired and in poor repair.

The group have now progressed to producing outdoor items such as mosaics, pots and colourful signage for the garden.

The group would like to expand further activities with the community artist as much more can be done to improve the space. They hope to produce a sculpture and hold an outdoor event during the summer for tenants to attend.

The complex supports over 90 people in total with 15-20 regularly attending various activities in the lounge.

All are over 60 and some have both physical and mental ill health.

Pam has worked hard to increase the confidence of the group members and encouraged them to challenge themselves. They have reported that the find the activities relaxing and feel that it reduces any worries and anxieties. The group are keen to do more and have expressed a wish to create some sort of permanent sculpture for the garden or local area. The group has built a good relationship with Pam and her enthusiasm and care has ensured that the group is fully accessible. Age and ability are not a barrier! Some of the tenants would never attend an "art" class and have enjoyed various activities they had not tried before.

The garden is still in need of improvement such as the repair of garden benches and the introduction of new plants and wildflower seeds.

The group also incorporated a visit from V & A staff as part of their community outreach programme and hope to build on this link in the future.

The group have made it clear they wish to continue and to improve the garden as much as possible.

Tenants who attend would not access art classes due to the costs, transport etc. They enjoy attending within the complex lounge as this is also accessible with disabled bathroom etc and easy access. Tenants also enjoy refreshments and have had external visits to the cafe at Botanic Gardens supported by the previous grants.

Although tenants have access to the warden service and the lounge, tenants can be isolated due to ill health or lack of social connections, family in the area.
