Please give a description of what you want this grant for - (please limit your answer to 500 words or less)

This will be the 24<sup>th</sup> year of the West End Christmas Fortnight. As in past years, we are planning to have a host of events for the whole community during the fortnight. We aim to replicate and add to the events we ran in 2023 as follows.

- Christmas Concert involving seven local primary and secondary schools, plus one nursery school.
- Talks both in person and on-line. Run over the fortnight, we would aim to have input from organisations such as those who have taken part in recent years :
  - City Archives
  - o Christmas Stories, partly aimed at children Dundee Libraries (LACD)
  - o Lifelong Learning Dundee joint online event

This year we intend to continue a small number of online events but will predominantly have face to face events as in 2022 and 2023.

- Christmas Memories event A new initiative for 2024, collecting Christmas memories from local elderly people with a reminiscences event during Christmas Fortnight at a sheltered housing lounge (Corso Street).
- Gate Church Christmas events including a community Christmas event aimed at children and families. This will be run again this year plus a Christmas Hymns event for older people.
- Community and Local Business Awards. Aimed at community groups and the local business community successfully run both in 2019, 2020, 2021 2022 and 2023. This is managed with the kind assistance of Harris Academy senior pupils.
- Art competition for P5, P6 and P7 children.
- Children's Crafts Event. Aimed at pre-school and young primary-age children
- Christmas Cards making event. A new event for 2024 following an offer from a local resident to run this as a free event.

- **Christmas Goody Bags.** Santa handed them to children at our Christmas Concert this year.
- **Botanic Garden activity.** We intend to again engage with the University of Dundee Botanic Garden to include events at the Botanic Garden.

Please note that, for the first time, WestFest is separately running the Christmas Lights and Christmas Market events and will apply to the Festive Fund. It has therefore been agreed with WestFest that it will apply to the Fesrive Fund and the West End Christmas Fortnight will NOT apply to that fund. In previous years, we have made separate bids to CRF and Festive Fund. This year we are therefore applying only to CRF. Only WestFest will seek business donations to avoid the same West End businesses being approached twice.

In addition, our overall funding requirement is now reduced.

Following the success of the Christmas market we ran in 2021, 2022 and 2023 and increased involvement of local businesses in Community and Business Awards, Dundee WestFest and West End Christmas Fortnight have agreed that henceforth the Dundee WestFest organisation will separately run the opening day of Christmas Fortnight with the two principal events within:

- Christmas Lights WestFest intends having a spectacular lights show along the Perth Road District Shopping Centre, Thursday 28<sup>th</sup> November 2024.
- Christmas Market As part of that Christmas Lights event on Thursday 28<sup>th</sup> November 2024, WestFest's intention is that a Christmas Market larger than that before run will also take place.

Therefore the Dundee WestFest organisation will separately seek funding for the Christmas Lights and Market day (including through a Festive Fund bid and business donations) and the West End Christmas Fortnight Committee has reduced its activities and funding bid to reflect that we will no longer run these.

#### Which City Plan / Local Community Plan Outcome(s) will it address?

This is a fortnight of events aimed at bringing the community together and the Christmas Fortnight committee specifically ensures that all members of the community can participate in all the events, irrespective of household income as

events are not charged for and all are welcome. Specifically, as successfully done in past years, we ensure that targeted families with whom the Children and Families Service are working with are encouraged to participate in the children's crafts event and this has in past years been particularly successful in attracting families for whom English is their second language to participate and feel welcomed at our events.

#### How many people will benefit from this project?

In previous years over 2000 persons

Will any specific groups benefit from this project? (male, female, age range or protected characteristic)

Around 300-350 attend the Christmas Concert – we are looking to have a visit from Santa, food and community stalls after the concert this year.

All five local primary schools are invited to participate in the P6 football competition and art competition.

Hundreds of residents took part in the shoppers' prize draw.

We involve all sections of the community including schools, care homes, all faith groups across the West End and all community and friends' groups. Over two decades we have through involving as many groups in the West End as possible achieved a real sense of community and including as many people as possible in a variety of events. In addition, we have sought to support and promote local businesses in the West End.

We very much promote a sense of community, celebration and "coming together" of everyone in the West End across our events and seek to involve all sections of the community from the very youngest to oldest in our events.

What local consultation has taken place regarding this application?

Our events involve co-operation between many community groups in drawing together a Christmas Fortnight – groups from the community council, local businesses, friends groups of the various parks/botanic garden in the West End, faith groups and other community organisations. In that spirit of co-operation and consultation, our organising committee ensures close consultation and involvement throughout the West End community.

Additionally, we always consult and involve all sections of the community throughout the planning process. Our meetings are advertised via Facebook and X/Twitter to encourage input and attendance from across the community.

The Christmas Fortnight is now into its 24<sup>th</sup> year and has had and continues to have strong support from organisations and individuals throughout the West End.
