# Please give a description of what you want this grant for - (please limit your answer to 500 words or less)

Our vision is that the School of Dance will be a long-term project which will tie in with Craigie High School, who we are merging with next year form the new East Campus.

#### How would it work?

S1-2 pupils would be provided with professional dance coaching on period 6 on a Thursday from former Braeview Academy pupil (Caitlyn Rose – Showcase The Street). This will be the first step onto the program. It will run year-round for 40 weeks per year and will be timetabled for the S1-2's. This class will be supported by our NPA Dance Leaders and PE staff, who will be mentored by Caitlyn in 2024-25.

S3-6 pupils will have the opportunity to attend the extra-curricular dance class on a Thursday after school (early evening) at no cost. They will participate in the annual Dundee Dance Festival to showcase what they have been learning at the club.

S3-4 pupils will be offered a free Dance Leaders Award teaching course in June each year, provided by Active Schools with placements in the primary schools shadowing the S5-6 pupils.

S5-6, pupils will be offered a place on the schools NPA Dance (SQA qualification) provided by Braeview and then (East Campus) PE departments. The NPA dancers will split their placement time assisting the delivery of classes at the S1-2 School of Dance with Caitlyn and leading the delivery of primary school classes under the supervision of Active Schools assistants and primary class teachers.

The idea is that pupils attending Braeview (and then the new East Campus) will have a full pathway for dancing, assisting and lead teaching when they come to secondary school. Eventually, we would expect our dance leaders to take on the role of delivering the S1-2 School of Dance as part of their placement, making the School of Dance a cost-free and sustainable programme.

Braeview Academy has recently achieved Gold School Sport Award status from Sport Scotland, one of only 5 schools in the city to achieve this. One of the main reasons we have become a Gold school is due to our pupil voice, through our pupil sports council (PSC).

Following our recent PSC meetings, it was very clear that the pupils would like Braeview Academy to become a School of Dance. Our school already has a School of Rugby and Basketball for both boys and girls which is funded by the school through PEF. The PSC feel that a School of Dance will provide great opportunities for the girls (mainly) who are less motivated by contact sports or team sports.

Our vision is that the School of Dance will be a long-term project which will tie in with Craigie High School, who we are merging with next year form the new East Campus.

The School of Dance is needed because many of our pupils are from families who cannot afford to pay monthly fees for community clubs and businesses to have the same dancing experiences as pupils from more affluent areas. This has become more apparent during the 'Cost of Living Crisis'.

Having a School of Dance with a professional coach, who is a former pupil and is successfully working a dance development officer will provide our pupils with inspiration. It will also provide our pupils with an opportunity to become dance coaches themselves or to gain confidence from being positive young leaders within their community.

What local consultation has taken place regarding this application? (Please attach evidence summarising the results of any consultation)

The Braeview Academy Pupil Sports Council conducted a Hands Up survey with the current S1 Girls and Active Schools utilised a MS Teams survey with the current P7 pupils from Ballumbie, Fintry and Longhaugh primary school parents to gauge the interest. The results were over 47 pupils are looking to participate in the S1-2 School of Dance in 2024-25 session.

Active Schools, Braeview Academy PE, Craigie High PE & Senior Management team all met to discuss the proposals and plan including costings and the roles for those involved.

### What evidence do you hold that the local community supports this application?

Recent pupil sports council meetings raised the concern that Braeview Academy needed more activities and opportunities for girls to continue the great work this year. The PSC conducted a 'Hands Up' survey with the current S1 girls.

A MS Forms survey was distributed to all current S1 and P7 pupils from Braeview, Ballumbie, Longhaugh and Fintry schools. The results of the surveys highlighted that 47 P7 and S1 pupils (45 girls and 2 boys) would like to be part of an S1-2 School of Dance Program. This is something our school cannot provide without external funding.

The 'Cost of the School Day Report' means that all our extra-curricular sports and activities are completely free to our pupils. Braeview Academy currently provides a number of staff volunteer led clubs at the school. The school also use PEF to pay for coaches for our popular Schools of Rugby (Dundee Rugby) and Basketball (Dundee Madson's). Braeview Academy also pay for the cost of transport (taxi's and busses) for our pupils to participate in sports games and festivals for all of our sports teams (Basketball, Football, Netball, Athletics, Dance, Disability Sports). However, the schools PEF doesn't stretch far enough to pay for a School of Dance coach.

How will the project / activity tackle deprivation or benefit those experiencing deprivation? (Refer to Section 1 of the Guidance Notes)

With the 'cost-of-living crisis' and the health of our young people (particularly teenage girls) we need to continue to provide as many high quality and free opportunities for our girls to participate in sports and physical activities.

Whilst some of our pupils parents can afford to pay monthly fees for community based dance clubs/businesses, many (most) of our school populations families cannot. Therefore, it is vital that we can provide these opportunities in the school setting, during the school day and in the early evening.

With funding, the S1-2 School of Dance and the S1-S6 Extra-curricular dance club will provide high quality dance classes, free dance leadership qualifications and mentoring opportunities for pupils from Braeview Academy at no costs to the pupils.

Through SEEMIS reports, we can identify the pupils SIMD levels. We have many pupils living in SIMD 1-2 desciles, and we are able to accurately provide this information for reporting.
