- This quote is valid only if accepted within one month and due to the uncertainty of material prices the rates being fixed until 31<sup>st</sup> May 2025 when the quotation expires and rates are subject to revision.
- 2 The offer is deemed to be as priced.
- 3 Variation in quantities may lead to a variation in rate.
- Any additional work including work associated with unforeseen physical or artificial obstructions will be charged on CECA daywork rate or as agreed.

- 5 Clear access must be provided for all plant.
- We accept no responsibility for the suitability and soundness of your prepared sub base. All levels must be checked and agreed. If main contractor has not achieved correct levels then Tayside Contracts have the right to withdraw their offer until levels are acceptable. If instructed to proceed by the main contractor or client the additional material will be charged at a rate of £130 per tonne calculated from a jointly agreed dip sheet. Standing time to be charged at £200 per hour when areas are not prepared, as agreed with the main contractor and Tayside Contracts to receive surfacing operation.
- 7 The quotation is based on **one** site visit to complete.
- 8 The quotation is not a fixed price and will be subject to remeasurement.
- 9 If you require us to carry out this work, the enclosed form must be signed and returned to my estimating department at the above address. Failure to complete the attached form along with your acceptance may delay commencement of these works.
