- The Physical & Environmental Improvement Fund is to provide financial assistance for community initiatives aimed at improving the local area through Capital expenditure. Capital expenditure is something of a physical nature including the acquisition, improvement or structural enhancement of an asset valued at £6,000 or more.
- The Youth Inclusion Fund is to provide financial assistance for community initiatives aimed at working with Children and Young People. Please give a description of what you want this grant for - (please limit your answer to 500 words or less)

This grant will allow us to provide a free festive afternoon celebration with food, music and entertainment for some of the most elderly members of our community. It will bring together elderly and vulnerable members of our local community, where they will be served a 3 course meal with refreshments, whilst also enjoying the entertainment as well as a dancing display from a local dance school. This helps address issues of isolation, whilst increasing levels of wellbeing and self worth for all of these individuals. The event will be open to older people living across the whole of the Strathmartine ward, and will be publicised accordingly. Transport will be provided by volunteers at no cost to any participants who are less able and who would otherwise be unable to attend, taking them from their homes, to the event and back home again to ensure that no one is left out.

A free raffle ticket is given to everyone attending the event, where between a few prizes purchased and a large number of prizes donated by parishioners and volunteers, it means that up to half of the elderly participants will win a prize, which always brings a lot of excitement to them all.

Last year was the first event we'd held in almost 3 years since Covid and was well attended and appreciated. We have been approached by a number of elderly folk who came along to the party last year asking if the party is back running this year, as they are looking forward to getting out and enjoying company again. Given the cost of living crisis at the moment this will also bring some relief where they will receive a good meal, refreshments and a warm space without worrying about costs for a little while.

Which City Plan / Local Community Plan Outcome(s) will it address?

People in Dundee will have improved physical health and mental well-being and will experience fewer health inequalities

Dundee will be a fair and socially inclusive city

How many people will benefit from this project?

Up to 100

Will any specific groups benefit from this project? (male, female, age range or protected characteristic)

This will be open to elderly people from the Strathmartine ward, up to 100 can be catered for but we would estimate it to be closer to 80.

This event will give elderly people the opportunity to come together, getting them out of their homes, allowing them to socialise with others and also meet new people, reducing the feeling of isolation at a time of year when it is dark and cold. Exercise will also be provided in the form of dancing for participants who are able and happy to join in. Elderly people need to be getting out and mixing with people without worrying about anything.

Also, without this support, a charge would have to be made for the event and this would exclude an increasing number of participants who would be unable to afford it given the financial situation at the moment.

What local consultation has taken place regarding this application?

Parish Council Social Committee, Sheltered Housing Complexes, homes and wider communities. Also the cosy space lunch on a Wednesday has brought more new people into the hall and we will advertise it there and at St Columba's weekly cosy space too.

No evidence as such, but given the cost of living crisis added to the fact many elderly people have barely left their homes in almost 3 years and the fact we've been approached or contacted by people who have attended the party previously and are eager to see it take place again.

It will bring together some of the most vulnerable people in society (elderly) at the time of year when isolation is higher due to the bad, cold & dark weather, with people not being able to get out of their houses much and also when concern about money is at such a high just now.

We have had real problems sourcing a caterer, apparently many caterers have given up since Covid and can only find this one willing to quote/cater. We are awaiting an updated quote for this year and have estimated £15/head and if it's over that the church will cover the difference.
