Campy Growers is a 9 acre community growing space in Camperdown Park, Strathmartine ward. Currently around 2 acres is veg growing space, and we have been developing an orchard in part of the remaining 7 acres. We currently have two members of staff (with an additional member on maternity leave for over 9 months). The garden is run for and by the community: volunteers are key to running of the garden and much of our veg goes to community larders including in Strathmartine and Lochee wards. Our charitable purposes are listed in section below. In the last two years there has been two aspects of our offer to the Community: 1) opportunities to volunteer in the Garden; and 2) attending workshops/events. This application relates to our community workshop/event offer.

The funding will be used to pay for a part-time co-ordinator to organise around 15 community workshops/events at Campy Growers, and monthly climate cafe sessions during 2025.

Workshops

With regard workshops, the role will be responsible for: finalising our 2025 workshop/event programme; contacting workshop leaders; outreach into surrounding communities and use of social media for raising awareness of workshops/events; organising bookings; organising volunteer / participant expenses; supporting workshop leaders to make sure the events run smoothly; and 'telling the story' of the workshop afterwards, eg on social media.

Over the course of the 2024, we identified a number of workshop themes for 2025 including: Gardening (including starting a garden, growing your own veg, botany, taking cuttings, soil health, mushroom growing...); Cooking from scratch (focusing on cooking healthy using seasonal produce from the garden); Biodiversity workshops (moth and bats workshops); and Community events (movie screenings, open days, harvest celebrations...).

We have a draft workshop plan developed during 2024.

Climate Cafes

These will be monthly group meetings open to all where people come to discuss concerns about the impact of climate change and practical ways in which individuals can address the issues, inspired by the Campy Growers growing space.

Funding to date for workshop programme

We have funding for the workshops/events themselves: workshop leaders' time, materials and volunteer expenses from two sources: Dundee Climate Fund including 9 workshops and monthly climate cafe sessions (including training); and DVVA 2025 level 1 funding for 6 workshops.

We are applying for Strathmartine CRF funding for a Workshop/events co-ordinator' to organise these worshops/events, and to raise awareness of them in the communities around us.

Our workshops are open to all, including families.

Our small team would like to create more sustainability and breadth to our workshop offer. In 2024, over 10 months, we ran 28 workshops with over 250 attendees, and 12 bigger events with over 1100 attendees in total. Feedback has always been positive and encouraging. However, many of the workshops in 2024 have been run by a single staff member, and we would like to extend the breadth of topics we can offer - skills and knowledge around food, cooking, nature and the environment - by bringing others in. Linked to this, a number of volunteers have expressed an interest in running workshops on different topics. Supporting them in this is the next capacity building step for our young project - empowering those involved with us and giving them a greater ownership in the running of Campy Growers. The workshop co-ordinator role offers us a resource to co-ordinate and support this effort, and reach out into surrounding communities to raise awareness of our workshops/events.

The time available to our two existing staff to communicate with local networks, raising awareness of what we do, is limited, and the workshop co-ordinator role would enable us to strengthen the community connections we have made over the last three years.

The approach we have in the Garden and what we see Campy Growers to be in the future is largely influenced by our volunteers' input. We have organised frequent tours of/talks in the garden to compile ideas, support volunteers in the projects they want to run. Many volunteers have expressed the desire to support or run workshops and, as a collective, we want to embrace this enthusiasm. We have established a list of potential workshops volunteers and professionals could and would want to run or contribute to. Having a dedicated staff member would enable us to make this happen.

What local consultation has taken place regarding this application?

Since 2022, we have run volunteer sessions; workshops around gardening, cooking and biodiversity; and we have started delivering vegetables to various locations around Dundee. By quadrupling our growing space since 2022, we have been able to show individuals and groups how to grow their own food, and distribute hundreds of kilos of nutritious, locally grown vegetables. We have a local impact by working with local schools, groups and food larders, and also have city-wide and national recognition: 'Outstanding' certification from Keep Scotland Beautiful; and we were one of three finalists from the BBC OneShow in September 2024.

In August 2024 alone, we were able to distribute over 600kg of veg. This went to local food larders, to local people, was used in food workshops and distributed through our veg box scheme. During the growing season we average 600 visitors a month (through open days, workshops, walk-in visitors...).

The general feedback about Campy Growers workshops has been very positive. Examples of feedback include:

"Campy Growers helped sow seeds for the 100 families projects. 10 volunteers were delighted to support other projects and came together to learn about growing media, types of pots and sowing methods. Together, we've sown over 2250 seeds!

"It inspired some volunteers who kept the "Big Sow" going at home and have sown many more seeds for their own growing spaces. "

"I have cooked so much since the cooking group. I got a small food processor and I am having so much fun. That's thanks to the cooking group"

"Thank you so much for letting me visit yesterday and taking the time out to show me round your amazing site. I love what you are doing here and all the different ways to grow and propagate your vegetables. Also for all the information, hints and tips I took away. Loved my goody bag, so delicious. Hope you have a great growing season and much success with your charity."

"Space is beautiful. Soup was amazing! particular thanks to the presenter who was very knowledgeable and enthusiastic and knowledgeable. First Class" Participant to the Stargazing night

The approach we have in the garden and what we see Campy Growers to be in the future is largely influenced by our volunteers' input. We have organised frequent discussions / garden tours to compile ideas, and supported volunteers in the projects they want to run.

Out of our 2024 workshop programme, many volunteers have expressed the desire to support or run workshops and, as a collective, we want to embrace this enthusiasm. We have established a list of potential workshops that volunteers and professionals could and would want to run or contribute to.

For example, we would like to run the following workshops which have received lots of positive feedback in 2023 and 2024: botany; start your own garden, making

cuttings, seed bombs, PYO session, moth events, bat event, cooking, veg stalls, big spring sow, big winter sow, gardening with kids and more.

During the high of the growing season (May to October) we had on average 500 volunteering hours a month in 2024 vs 400 hours in 2023 which shows the growing interest in the project. The empowerment through volunteering is leading to volunteers wanting to take more ownership of the project and run or support the delivery of workshops:

- Some volunteers would like to run gardening sessions such as botany for beginners, the 'big sow', or cooking sessions using produce grown on site.
- Others would like to focus on specific projects and connect with other likeminded people for e.g. biodiversity events, pond building, wildlife identification etc.
- New users are also offering to come to Campy Growers to share skills they gained through work or previous experience and would like to contribute to Campy Growers charitable purposes (nutrition and food, soil workshop, bats and moth night, jam making ...).

To deliver the project, we have identified volunteers interested and ready to run a

workshop as well as volunteers who would like to shadow and become more confident.

We think that being able to come to workshops around food, health and nature potentially empowers people to take control of their lives in many ways, counter-acting the impacts of deprivation:			
- Offering people the skills to be able to grow their own food			
- Offering people the skills to be able to cook healthily and seasonally			
- Motivate people to take control of their basic needs – food and exercise, with positive impacts for physical and mental health			

- Develop new interests food, cooking, nature and the environment that can help bring purpose to people's lives
- Meet new people at workshops at the garden, helping people build community' and counter-act loneliness.
- Coming to a workshop is a reason for many people to come to the Campy Growers garden and connect with a biodiverse green space (9 acre site), often a kind of 'natural' therapy for difficulties in a person's life.
