

- 2. Value Added Tax. The prices listed do not contain V.A.T. This charge will be levied on all items, where applicable.
- 3. Terms. All prices are subject to alteration or correction without notice and orders are accepted on the understanding that the price that will be charged is that quoted on acceptance of customers order. This does not affect fixed-price contracts. Payment is due within 30 days following the date of invoice. Prices do not include installation costs.
  4. £30 is our minimum order value. Carriage will also be charged on a minimum order.
  5. Cancelled Orders. Sutcliffe Play will be entitled to recover any costs incurred up to the time an order

- 6. Storage. If delivery or collection of goods is delayed through any act or omission of the Customer, Sutcliffe Play may put the goods into storage at the Customer's risk and expense.
- 7. Carriage U.K. Mainland. 10% of goods value up to £2,500, 7.5% of goods value between £2501 and £5,000, 4% of goods value over £5,000. Other carriage charges on application. Deliveries before 10am incur an extra charge of £150. Carriage is calculated on the list price and subject to a minimum of £15 8. LG (Lifting Gear). This is an additional cost of £150 to normal carriage charges and covers all types required but does not cover installation. Items with (LG) require more than a forklift truck for handling. Please discuss requirements when placing your order.

## Across the play marketplace, our products are renowned for quality, durability, and sustainability.

As a UK manufacturer supplying local authorities across the country, Sutcliffe Play is fully aware that our equipment may be targeted for vandalism. As such, our equipment is designed to be as vandal-resistant, robust and maintenance-free as possible, even in challenging environments, ensuring its play value is retained throughout its life. To help achieve this longevity, when designing and manufacturing our equipment we only specify high-quality materials and use tried and tested construction methods.

#### Warranty periods

We offer market leading warranties with all of our equipment, offering peace of mind that our equipment will continue to perform as it was intended and as supplied when new.

#### Warranty exclusions

Vandalism, misuse, discolouration and failure as a result of poor maintenance or installation by others. All Sutcliffe Play equipment must be maintained in accordance with the Sutcliffe Play maintenance instructions.

#### **Lifetime Warranty**

Against structural failure due to material or production defects on Sutcliffe Play manufactured mild steel, stainless steel and aluminium components.

Against cracking, splitting and delamination of HDPE & HPL panels that are part of Sutcliffe Play manufactured products.

#### **15 Year Warranty**

Applicable to engineered softwood, hardwood and laminated components where structural integrity is compromised on playground equipment.

Where the galvanised finish is defective causing material failure on Sutcliffe Play products.

#### 7 Year Warranty

Where the zinc-rich powder coated finish is defective causing material failure on Sutcliffe Play products.

Where the anodised finish is defective causing material failure on Sutcliffe Play products.

#### **5 Year Warranty**

Steel-cored rope, MUGA mesh & anti-slip deck, against structural failure due to material or production defects.

Coloured wet pour against faulty materials or inappropriate application. Does not include coloured wetpour inserts into black wetpour or joints between wetpour pads and any perimeter edging.

Artificial carpet against failure due to faulty materials or improper application.

#### 3 Year Warranty

Bearings & springs, against structural failure due to faulty workmanship or materials

Rubber, where used as a surface finish having been subjected to a vulcanising process, against failure due to faulty workmanship or materials.

Black wetpour, against faulty materials or inappropriate application. Does not include coloured wet pour inserts into black wetpour or joints between wetpour pads and any perimeter edging.

Rubber grass matting, against structural failure due to faulty materials.

Rubber mulch, against faulty materials or inappropriate application. Does not include joints or any perimeter edging. Does not include colour fastness.

#### 1 Year Warranty

Installation, accordant with the product installation instructions used at the time of installation.

Against failure of other moving parts due to faulty workmanship or materials.

#### **Sutcliffe Play Lifetime Philosophy**

In addition to our standard warranty periods, any customer concern, regardless of the age of the product, is fully investigated, and free of charge components supplied in circumstances where it would be reasonable to expect a greater life from any given part. This philosophy requires equipment to have been adequately maintained by the customer, in order to avoid failure as a result of damage sustained outside normal wear and tear.

Rubber and timber are two of the world's most widely used natural materials and both are used within our manufacturing facility, rubber being the main raw material used to mould our swing seats and timber the construction material for our Orchard and Treetops timber ranges, are all supplied from sustainable sources.

Timber being FSC and Rubber extracted from Global Platform for Sustainable Natural Rubber (GPNSR) approved farms.


## Where we are now...

We are committed to reducing the impact that our business has on the environment through assessing and improving our environmental performance.

With a 35% reduction of carbon emissions achieved over the past 3 years we strive to be carbon neutral by 2040.



In 2017 the company started to switch its fleet of vehicles to either fully electric or at minimum PHEV, significantly reducing the carbon generated from the essential need to mobilise our customer-facing staff.



We have reduced our gas consumption by

y making changes after a review underlaken in early 2022, of the heating and appliances used to support the manufacturing and offices buildings.

#### **Emissions Reduction**

Reduction in the emission of carbon dioxide from the manufacturing process incorporates both small local level initiatives as well as the larger more strategic improvements.

Our electricity is from a

#### 96% renewable

source that is certified by an EU Guarantee of Origin to prove the power comes from a renewable source.

Under the 2005 Fuel Mix Disclosure Regulations our energy provider confirms that 96.3% of the electricity procured is from sources which include Wind Turbines, Solar Panels and Hydro Power Schemes.

#### Reducing emissions

The emission reductions made at our manufacturing site, the ethos of local raw material supply and with our mobilised staff being carbon efficient, are all a reflection in the low kgCO2e rating of the products that we produce.



#### **Eco-friendly delivery**

Consideration should also be given to the environmental impact of transporting the goods beyond the manufacturing site. Road and sea haulage are one of the largest emitters of kgCO2e.

Governments throughout Europe, including our own, are now focusing on reducing this large scale emitter of harmful GHG attributed to damaging both the environment and the direct health of the population.

To our customers, Sutcliffe Play brings the added environmental benefit as all our haulage transportation is Euro 6 compliant and travelling just a short distance from the site of manufacture to your door.
