Due to local demand & in line with the East End Community Plan 'We need to respond to the cost of living crisis' & 'We need local opportunities to be involved in learning, social and physical activities which promote wellbeing'. The East Youth Team in partnership with Douglas Management Group run a successful children's work provision, weekly on Wednesday & Thursday evenings after school for local young people under 10 years old. The Clubs are split into Wednesday night P1 – P3 & Thursday night P4 – P6 there are on average 40 young people accessing the sessions weekly. Staff will continually promote and publicise to local primary schools in the area to inform local children of the provision we are providing using posters and through the Youth Team who attend the primary schools. Weekly sessions consist of physical activity, arts, IT access, along with themed workshops and activities that promote positive health and wellbeing and provide informal learning experiences within an accessible and inclusive environment. The funding would enable staff to deliver a weekly provision for children aged 10 and under for 43 weeks, as well as delivering 4 experiential learning trips through the school summer holiday period.

The funding also enables the team to purchase resources and equipment for the weekly sessions, activities and create workshops that provide new learning opportunities for local young people to develop friendships and relationships and build self-confidence.

The funding also helps us to address food poverty & food insecurity by providing healthy food and snacks to the children at every session and enables us to employ temporary staff to deliver fun and engaging diversionary sessions to those most likely to experience inequalities and poor outcomes in health, wellbeing and education.

As well as term-time provision, we offer holiday activities & trips throughout the school holiday periods. These consist of full day excursions to as well as celebrating holidays such as Valentine's, Halloween and Christmas where we support bigger community events in partnership with the Local Management Group. In addition to the school holiday trips the funding enables us to offer local young people with the opportunity to attend the annual Pantomime at Whitehall Theatre Dundee, this is a very popular trip with the young people feeding back just how much they enjoy the night.

Without the funding the weekly provision and the trips could not be delivered

With figures published for 2020 SIMD for the East End Ward, it shows that the child population in most deprived areas has risen from 44.7% in 2016 to 54.9% in 2020 and children and young people living in the East End are now identified as the most deprived in Dundee. This funding allows us to tackle some of the barriers associated with deprivation and to deliver Children's Groups in line with the East End Local Community Plan.

There is an identified need for this type of provision in the Douglas area as there are limited opportunities to participate in this type of children's group.

Over the past year or so, we have had requests from carers who are caring for looked after children, living in the Douglas area as well as requests from other partners such as Education and Social Work.

This provision allows workers to engage with local children and families, developing relationships which provide earlier interventions and enables youth workers to sustain connections when young people transition from primary to secondary school. It is more likely that young people will access youth work provision if earlier intervention has taken place.

The project also creates volunteering opportunities for older young people within the local area. Young people are identified from other diversionary provisions to become young volunteers, developing transferable skills for learning, life and work. The volunteers work towards achieving a Saltire Award for their commitment, as well as other relevant awards such as Dynamic Youth or REHIS.
Inline with the local East End Community Plan, East End residents have shared their concerns about the impact of the rise in cost of living. SIMD 2020 data shows increasing levels of income depravation in areas of the East End.
Inline with the local East End Community Plan, Parents and careers have expressed a need for local family activities.

New activities and ideas for the summer experiential learning trips are welcomed from the young people, Parents, carers and by the centres Management Group members

This group receives ongoing support from the Douglas Community Centre Management Group.

Young people are targeted within local primary schools and through community engagement and a the East End Ward is top of the SIMD for Dundee, these young people are most isolated ar disadvantaged. The project will offer young people the opportunity to take part in a range diversionary programmes and increase physical and educational opportunities for young people across the local area.
The provision is open to all children living in the Douglas and Craigie areas of Dundee. Children fro low economic backgrounds are encouraged to take up places when available and we work close with partners to ensure that places are being offered to those most vulnerable. The provision promotes social inclusion and is an excellent, low-cost provision, delivered by experienced, friend staff and young volunteers, in a safe and fun environment.
Youth work is an informal education process contributing to young people's learning ar development. Our Youth work is underpinned by National Outcome 4 (Curriculum for Excellence and SOA 3 (GIRFEC) and the services we provide are shaped by the local community planning process.
