Giving Back are looking to develop a substance use, mental health, benefit and advocacy service called Forma Mentis in Broughty Ferry. This service will work within community buildings and plans to have groups running from the Sakura Community Café building. The service will also do visits to other services and home visits to community members.

This grant will enable the staff to have access to the laptops and phones to contact participants and enable them to make applications on laptops for benefits, mental health support and substance support and to stay in touch with services and assist in the delivery of provision for the community.

The phones will enable the staff to contact community members, complete home visits while the service is in development and have access to a phone to call the benefit services as well as being able to contact other staff in relation to the risk assessment for home visits.

The Posters and Flyers will enable a greater community connection and make the service more known and accessible to people. Having the posters in the more deprived areas and linking in with the Chemist in this area will enable the participants and community members to have a better support system.

We need better support for people in recovery and their families

#### How many people will benefit from this project?

Will any specific groups benefit from this project? (male, female, age range or protected characteristic)

Individuals in the community who are on benefits, unemployed and on a lower income will have access to this service.

**Please say why the project is needed** (please limit your answer to 500 words or less) At present Broughty Ferry is seen as an affluent area and this can cause problems to the community members who are in poverty or struggling with their income. Due to being in a DD5 post code there is less accessibility to services and support. We plan to develop a service that is based in Broughty Ferry and can supply this service for the community which is at present a gap in service provision.

Since 2016 Broughty ferry has decreased to the 20% most deprived in some areas for crime, income, unemployment, housing and health as stated in the SMID. We need to be developing services in the area to prevent an even greater decline in the community. We plan to work with the community to try to develop these areas and assist in the development and growth of the community need by having more access.

What local consultation has taken place regarding this application? (Please attach evidence summarising the results of any consultation)

The Founder has been in discussion with the schools in the area, the parents and some local community members who are keen to have more support in the area. This also links to the LCPP.

We are aware of the areas decrease in the SMID and how some areas are now in the 20% most deprived in Scotland. We plan to work in these areas and link to services to develop access. We have had discussions with the chemists in the area and they have raised a need for assistance to community members who have a substance use issue and are looking forward to Forma Mentis being available to the community in January.

The Community team will start in January and will make connections with DDARS, We are with you and the chemists in the area to assist with substance use and mental health in the area. We will also be able to complete 1-1 appointments in peoples houses to assist with substance use, mental health, benefits and advocacy.
