Please give a description of what you want this grant for:

-CCSH opened the 3G pitch in the Craigie High School Campus on 13 January 2016. At that point it was hoped that all users would comply with the rules re utilising the appropriate footwear which would best protect the synthetic grass turf. While most member clubs complied with that rule it was difficult to control the Craigie pupil's footwear. The impact was that the turf after 9 years has become the worse for wear and we are now having to replace the carpet in the Spring or Summer of this year. You will see from our accounts that we have been preparing for that costly day. We are confident we will have sufficient funding in place for the work. The SFA are supporting the project financially to help.

-The school is readying itself to decamp to the Dundee East Campus in July this year. But in lieu we had already taken on board the local "after school club" with 30 primary pupils attending for snacks (Mon to Friday) at the Craigie pavilion at 3.15 p.m. Then, football or fun sports start on the 3G afterwards with planned leisure activities indoors held in the new 2017 constructed pavilion. This is followed by an early evening meal with the day ending at 6.00 p.m. This undertaking by qualified DUSC coaches lasts for the full year Mon till Fri with football camps an option during the school holidays for that group and others. 2024 which details what our "after school project" is all about.

-With your contribution we wish to equip the above 30 youngsters with appropriate footwear, firstly to protect the 3G from wear and tear, but foremostly to ensure that many of the deprived families connected with our group are not faced with purchasing the specialist footwear needed to participate in 3G activities.

-DUSC also manage 26 young, youth and girls' sides numbering collectively 750 attendees per week at the 3G and we have estimated as per the attached quotation below what we need in terms of footwear for our more deprived users as well as the "after school group". So, we are looking for 139 pairs of boots in total. There is also an active" Fun Fours".

-In addition to the above young people's activities we also run dance classes at our Huntly Square dance studio. The group are about to "go public" and we wish to purchase standard and printed dance attire/dress at a minimal cost (£750) to show conformity.

Which City Plan / Local Community Plan Outcome(s) will it address? (see also below)

The Youth Inclusion Fund provides financial assistance for community initiatives aimed at working with Children and Young People. This application connects significantly with children & young people providing enjoyable activities, diverting them from undesirable activities that may often prevail in their locale.

How many people will benefit from this project?

139 New (+29)

Will any specific groups benefit from this project? (male, female, age range or protected characteristic)

- Over 420 young people, both male and female are members of CCSH/DUSC. They are all between 4 and 17 years old. Only those selected within the quotation attached (139) will benefit from this "footwear" project. But both boys and girls will benefit. Historically the remaining 280 or so have provided their own boots. Note: most of that group are involved in competitive football. In addition, the application also caters for 29 dance studio participants – the +29 above.

The project is needed

1, to help alleviate hardship that parents may incur financially to acquire appropriate footwear to enable their children to participate in 3G and other sporting activities run by DUSC and CCSH including dance classes indoors in the Huntly Square dance studio.

2. to help alleviate the future wear and tear in the resurfaced pitch that we have experienced with the current 3G pitch – part of which is thought to have occurred through the use of inappropriate footwear.

3 to reduce social isolation of those who may be inhibited accessing the 3G because of their financial constraints. It is worth noting that the cost of hiring the Craigie 3G is cheaper than any other of the 3G's in the Tayside Region. Thus, this initiative also keeps parenting costs down.

4.to enhance the objectives of the Local Community Plan for Dundee's East End.

What local consultation has taken place regarding this application? (Please attach evidence summarising the results of any consultation)

The main consultation with local residents took place in 2015 when the 3G was in its planning stage. Experience gathered for this project has been provided by the feedback from our many qualified coaches and 100 or so volunteers who have often been involved with their age groups for many seasons and "know about" the families' circumstances by virtue of this continuity. We wanted to do this in 2016 but could not find a sponsor at that time.

What evidence do you hold that the local community supports this application? (For example, was it proposed by members of a particular group? Does it directly address need identified by community members?)

There are over 100 local volunteers from the community managing the 26 teams, with a squad of paid coaches managing the "after school club". Through their feedback we know which families will appreciate help. This application is another small step towards improving families existing economic circumstances.

As already said, Craigie 3G rental costs are the lowest in the area. This together with in-house initiatives to raise funds internally – e.g. holiday football camps etc. – already curtail what we ask families to contribute towards their children's sporting endeavours. This initiative adds to the already healthy fund raising that occurs inhouse by our volunteers.

Although we have been unable to attract direct funding for this initiative, we have had great success in fund raising generally and this is well documented. Importantly we have a partnership with Club Sport Dundee which guarantees that we are purchasing the 139 pairs of boots at wholesale price rather than retail. This provides a saving of one third overall or approximately £1,422 when compared with the retail price.

How do you intend to monitor the project Outputs and Outcomes?

There will be admin procedures implemented for controlling the distribution and recording of boots to individuals and a register of recipients will be kept. Coaches will monitor as closely as possible the footwear being used when on the 3G with their teams. Signs will be attached to the main entrances about what is appropriate footwear and what is not. There will be monitoring reviews by paid staff of the outcomes especially using practices we have already in place.
