Yusuf Youth Initiative has been working closely with the Huntly Square Gym to reach out to our service users in the Ferry area. YYI works closely with young people from Grove, Craigie High, Craigie Barns and Forthill primary. The gym provides confidence building, skills award for the Duke of Edinburgh and and overall fitness that improves physical and mental well-being.

The sessions run 6 times per week for different age groups. YYI supports 60 young people per week across the different sessions. The cost per session is £15 which covers instructor and venue costs.
