Angus Housing Association (AHA) is a local registered social landlord with approximately 2,200 properties across Dundee and Angus.

For over 14 years, AHA has been involved in delivering the Housing Education and Young People (HEY) Project, a multi-agency initiative developed in response to rising levels of youth homelessness in Dundee.

The HEY Project is delivered in partnership with Dundee City Council Homeless Services, Action for Children, and The Corner. It provides secondary-aged young people with clear, age-appropriate information about housing options, homelessness, anti-social behaviour, and the support services available to young people who are at risk of homelessness.

The project focuses on early intervention and prevention by improving young people's understanding of housing systems, tenancy responsibilities, and the factors that can put them at risk of homelessness.

In recent years, the sustainability of the HEY Project has been challenged by reduced capacity across partner agencies. Action for Children, previously the lead agency, no longer has the capacity to coordinate or deliver the programme due to budget reductions and staffing changes.

Dundee City Council was approached to assume a coordination role, but was unable to do so due to similar resource pressures. In response, Angus Housing Association has taken on an interim lead role to ensure delivery continues, including liaising with schools and partners, developing timetables, adapting content to meet individual school needs, and supporting delivery. This work has been resource-intensive and has placed significant pressure on existing staff while maintaining core service delivery.

It has become clear that the continued delivery, development, and expansion of the HEY Project requires a dedicated post. Funding is therefore sought to support a full-time HEY Project Co-ordinator, whose sole remit would be to coordinate, develop, and deliver the HEY Project across Dundee secondary schools, strengthen partnerships, and ensure the programme remains responsive to local need.

The HEY Project Co-ordinator post has been calculated at Grade 4, with a total cost of £49,500 per annum, including salary and employer costs (e.g., National Insurance and pension contributions). The post would be advertised as a full-time (35 hours per week), one-year fixed-term contract, with the option of a secondment. Angus Housing Association is committed to supporting 50% of the cost of the post. Contributions are being sought for this financial year to meet the remaining costs, and we will continue to seek and apply for additional funding to sustain the post beyond this period.

Funding is being sought from Dundee Partnership forums to contribute towards the remaining 50% of the project cost, with part-funding requested from each forum to support delivery for one year. During this period, the project will be evaluated in partnership with delivery agencies and schools. Subject to evaluation and discussion with partners, Angus Housing Association will work towards maintaining funding and mainstreaming the post to ensure the long-term sustainability of the HEY Project.

Which City Plan / Local Community Plan Outcome(s) will it address?

This proposal directly contributes to the Dundee City Plan 2022–2032 outcome of creating a Fair and Prosperous Dundee by improving access to housing advice, preventing youth homelessness, and supporting young people into stable accommodation. It aligns with Local Community Plan outcomes that seek to ensure people live in affordable, secure homes; that children and young people have improved life chances; and that communities are resilient and supported through early intervention.

Outcome:

People experience less poverty and inequality and have improved life chances.

How the project contributes:

The post will support young people experiencing or at risk of social housing need and homelessness by providing early intervention, housing advice, and support to access and sustain suitable accommodation. By preventing homelessness and reducing housing instability, the post will help remove barriers linked to poverty, poor health, and limited educational or employment opportunities.

Outcome:

Children and young people have improved life chances and are supported to achieve positive destinations.

How the project contributes:

The post will focus on preventing youth homelessness and supporting young people to understand housing options, access social housing, and sustain tenancies. This work supports safer transitions and reduces the risk of crisis homelessness.

The post will strengthen local homelessness prevention by providing advice to young people. It will support access to social housing pathways, improve understanding of tenancy rights and responsibilities, reducing homelessness. This supports Local Community Planning priorities to reduce homelessness and increase housing stability at a community level.

<p>Please say why the project is needed (please limit your answer to 500 words or less)</p> <p>Recent homelessness statistics highlight the urgency:</p> <ul style="list-style-type: none"> • 28% rise in households in temporary accommodation (2023/24) • 404% increase in breaches of the Unsuitable Accommodation Order • Emerging risk of systemic failure identified by the Scottish Housing Regulator (2024) • Young people aged 18–25 account for 34% of homeless applications <p>Youth homelessness continues to be a significant and growing challenge in Dundee, driven by wider pressures including housing supply shortages, poverty and inequality.</p> <p>Recent data shows that homelessness demand in the city is increasing at a time when access to permanent accommodation and temporary housing options remains severely constrained.</p> <p>In 2024/25, 1,638 homelessness applications were made to Dundee City Council, representing an 18% increase on the previous year (Scottish Housing News, 2025; Dundee City Council, 2025a). Of these applications, 1,259</p>

households were assessed as homeless with a duty to rehouse, and 776 households were still awaiting an offer of permanent accommodation at the end of March 2025 (Dundee City Council, 2025a).

The number of households in temporary accommodation also increased significantly, with approximately 1,416 households living in temporary accommodation during the year, reflecting a 20% rise in demand (Dundee City Council, 2025a).

Young people are particularly vulnerable within this context. Dundee's Strategic Needs Assessment identifies that the city has one of the highest homelessness application rates in Scotland, strongly linked to deprivation, low income, and housing instability (Dundee Health and Social Care Partnership, 2021). Young people affected by family breakdown, experience of care, financial insecurity, or poor mental health are at heightened risk of homelessness, particularly where early support and advice are unavailable.

While Dundee's Rapid Rehousing Transition Plan (RRTP) focuses on rehousing people as quickly as possible and reducing time spent in temporary accommodation, it also recognises that rising homelessness demand cannot be addressed through crisis response alone (Dundee City Council, 2025a). The continued increase in applications highlights the urgent need for strengthened prevention and early-intervention approaches, particularly for those at greatest risk of entering the homelessness system at a young age.

There is a clear gap in preventative housing education and support for young people, particularly within school settings. Schools provide a vital opportunity to engage with young people before housing issues escalate, including those experiencing hidden homelessness, overcrowding, or family instability. Many young people enter adulthood without a clear understanding of housing options, tenancy rights and responsibilities, or how to access support, increasing the likelihood of homelessness during key transition points.

By raising housing awareness, improving access to support, and acting earlier, the project will reduce the risk of youth homelessness, support smoother transitions into adulthood, and advance Dundee Partnership priorities on early intervention, reducing inequality, and improving long-term outcomes for young people.

What local consultation has taken place regarding this application?

No formal local consultation was carried out specifically for this funding application. However, Angus Housing Association held a small-scale evaluation session with Braeview S6 pupils two years ago to identify the housing information young people felt was most important. The project has also been shaped through ongoing planning and review meetings with partner schools and delivery staff, with session content and delivery adapted in response to feedback and emerging issues.

The proposal is informed by local evidence and strategic priorities identified in the *City Plan for Dundee 2022–2032* and *Local Community Plans 2022–27*, which highlight rising homelessness, the importance of early intervention, and the need for targeted youth homelessness prevention aligned with local and national priorities.

What evidence do you hold that the local community supports this application?

This application is supported by ongoing demand and engagement from local schools and partner services working with young people in Dundee. The project has been developed through regular planning and review meetings with education, housing, and third-sector partners. Schools have actively requested delivery and worked collaboratively to ensure that this is part of the S3 plus PSE delivery.

The application also directly addresses locally identified needs and priorities set out in the *City Plan for Dundee 2022–2032* and *Local Community Plans 2022–27*, particularly around rising youth homelessness, inequality, and the importance of early intervention.

How will the project / activity tackle deprivation or benefit those experiencing deprivation? (Refer to Section 1 of the Guidance Notes)

This project focuses on addressing inequality and supporting young people in regeneration areas who are potentially at risk of housing instability and youth homelessness.

Housing insecurity is a key driver of deprivation and is closely linked to poor health, lower educational attainment, and reduced life chances.

The project delivers early-intervention and preventative support through schools and community settings, removing barriers associated with deprivation, including lack of knowledge about housing options, tenancy rights, budgeting skills, and access to support services. Delivery takes place within existing educational settings and is free at the point of access, ensuring young people from all households can participate without financial, transport, or confidence barriers.

By supporting young people to make informed housing choices and access help earlier, the project aims to reduce crisis homelessness, reliance on temporary accommodation, and repeat disadvantage, directly contributing to Dundee Partnership priorities around fairness, inclusion, and improved outcomes for those living in areas of deprivation.
