Greet, Eat and Meet is a community group that takes place on a Wednesday every week in Ormiston Lounge from 3.30-5.30pm.

The group was developed to tackle some of the issues associated with fuel poverty and the cost of living crisis and is part of the cosy spaces initiative. The group is free and open to anyone in the community and food is provided every week for those who attend. In addition to this, there are other benefits for those who attend the group such as reducing social isolation and connecting individuals and families to other services in the community.

The group has become a safe space for individuals and groups to express any concerns and through weekly meetings, issues have been identify which has led to interagency referrals and internal and external services offering support to individuals.

The group is attended by people of varying ages from primary seven to older people; anyone age 12 and over can attend, those under 12 have to be accompanied by an adult.

Angus Housing Association work alongside You Are Not Alone and Dundee City Council Literacies Team and have external services attend the provision. Police Scotland and The Community Empowerment Team have recently attended to engage with local people in attendance as have volunteers from You Are Not Alone and staff from Angus Housing Association including the Financial Inclusion Team.

In addition to this, the group is promoted through Facebook and in newsletters and through leafleting and networking with other services.

The grant will provide the cost of a weekly food budget for those attending on a Wednesday, a meal is always provided and if the budget allows, those who wish to take away recipes and ingredients are offered this option. Staff have attended The Community Cookit and Rehis course and use recipes that focus on budget cooking and healthy eating. During the year thematic community events are delivered as part of the GEM programme such as Easter, Christmas and more recently Burns Supper which tend to be more popular with increased attendance from the community.

The funding will also support the cost of refreshments such as tea, coffee and fruit juice.

Angus Housing Association would like to continue the community events as part of the GEM programme and would like to request some funding to provide a sports coach during school holidays and towards a Halloween Glow Sports Session.

Angus Housing Association provide the venue and to kitchens and staffing for the project in addition we have resources and facilities such as games and tv for movie nights and children and older people who attend.

The biggest attraction for those who attend is the food and refreshments as well as a warm space, the opportunity to socialise and thematic events and activities at different times of the year. More recently, we have seen an increase in the number of older males who attend and this has led to some individuals accessing other community groups.

The group is free of charge to all, no donations requested.

Due to the impact of the increase of the cost of living and fuel poverty, there is a need for free food provision and accessible warm spaces that provide local people with opportunities for support services and information.

Feedback from those who attend has highlighted that they enjoy getting out of the house. Some older people who attend live alone and the group provides an opportunity to reduce isolation and for different generations to engage with each other.

In terms of deprivation, the North East has a higher percentage of children living in poverty (36%) compared to the Dundee average of 31% (SIMD 2020)

As a social housing landlord, Angus Housing Association are aware of and have discussed the impact of rising costs in fuel, food and general living expenses with tenants. People who access the provision know that they will have access to free food, activities and agency support through access to the provision.

Those who attend GEM are consulted on the provision and how they would like it to develop. In addition to this, Angus Housing Association Tenants have recently taken part in conversations regarding rent proposals and have expressed concern in relation to the cost of living increase.
