On 29<sup>th</sup> of November 2025 Mid-Lin Day Care Centre are holding a Christmas Light night for the local Community. This event will be from 6pm-8.30pm. The event aims to provide a safe and warm environment for the local residents who at that time of year find it increasingly difficult due to the rising cost of living. Santa clause will be in attendance. Warm seasonal snacks and food parcels are to be given out to everyone as well as a being able to attend a Christmas party. A craft station and a light switch on for the full family will also be part of our evening. The area we are based in is in the most deprived 10% on SIMD 2020.

Being able to provide essentials such as food, heat and safety is becoming increasingly challenging each year. Mid-Lin's desire is to alleviate some of these difficulties for a short space of time and support its local community to provide some essential Christmas magic to its residents. A lot of children do not have the opportunity to get to meet Santa as it has become commercialised which had led to staggering costs for such a magical moment in a child's life. Every child deserves the right to meet Santa Claus, enjoy a warm space with fun activities and most of all feel safe.

This event will be advertised on our social media platforms, within the local schools posters will be advertised that I will ask the school art club to help us make. Through the schools Seesaw platform which reach all but 5 families within the school. Posters will also be placed within the local library, newsletters and shops to ensure all residents are invited. I will source a wide variety of seasonal craft activities as well as a vast amount of food to create food parcels to be taken home as well as seasonal snacks for the evening and a gift for each child to be given by Santa Clause. Last year Santa had over 80 children visit him in Mid-lin as well as 100 food parcels being handed out to local families when leaving the event, residents expressed how important it was to have basic food items in their home and that getting these can be a challenge.

We would like this year to do more as life continues to be more expensive and challenging for many within Linlathen as we can see the real benefit that hosting these nights has for the local community.

- "We need local opportunities to be involved in learning, social and physical activities which
  promote wellbeing" This local event will be an opportunity for people to socialise with their
  neighbours ands friends, an opportunity to reconnect with their local community and feel
  part of something. Everyone deserves to feel part of something regardless of circumstance.
- "we need to improve life chances for children and families" Providing a local, family-based activity at the most magical time of year will bring families together. Provide a safe and warm space for them to participate in activities whilst provide essential opportunities for them to engage with their peers.

#### How many people will benefit from this project?

Around 100 families within the local area will benefit from attending the Christmas light night. Each child will receive a gift from Santa which will be obtained for a local business owner. Each family regardless of gender, age or protected characteristics will receive a food parcel to help support them during one of the more difficult seasons within the year.

This figure is based on the number of families that attended the Christmas light night in 2024. Each
year it has grown therefore we hope to reach more families in 2025.

By inviting all of the local community to the day center for 2 and half hours, that is two and a half hours of their time, families do not need to worry about heating their home, worrying if they have essential food and fluids for their family. Feeling concerned about where they can go to be safe. An opportunity to engage with like-minded individuals within the area. Being invited to a welcoming and positive environment will support mental health which many people within deprived areas are affected by.
Within the city 10,208 children aged 0-15 live within the 20% most deprived data zones. This accounts for 43.4% of children in Dundee therefore, Mid-Lin Day Care Centre hopes to reach as many of these children and enhance their lives around the most magical time of year.
