Please give a description of what you want this grant for - (please limit your answer to 500 words or less)

During school holidays, the youth work team offer a range of learning opportunities and fun activities aimed at providing ongoing support for local young people.

In consultation with young people a holiday plan is proposed which will include daytime delivery four days a week as well as trips out of Dundee by coach and minibus.

Recognising the principles of dignity in food insecurity, we look to provide free access to food for all young people attending youth work provision.

This is usually a staple of sandwiches and healthy snacks, enhance throughout with hot meals, a menu which is designed by young people and prepared by young volunteers supported by youth work staff.

We look to expand the horizons for young people by offering trips and experiences that they could not otherwise. The large trip proposed to M&Ds has previously funded by CRF, has seen several hundred young people from across the city enjoy a big day out at the only theme park in the country.

The smaller excursions to nearby country parks and beaches are an extra treat that many local families could not afford for their children.

Leadership training residential.

A number of young people aged 14 – 16 who enjoy taking a lead within activities and consulting, planning and organising activities for others have been invited to work towards becoming young leaders or volunteers within their groups. Most have already undertaken our Peer Education programme and developed some basic skills in leadership and communication. The opportunity of a leadership training residential would develop their skills to take their roles a step further into volunteering within their own groups and also within other community groups. The leadership programme will comprise of accredited training in first aid and food hygiene certificates, along with workshops on child protection and further developing communication, groupwork, leadership skills, and a sense of responsibility to equip young people with the necessary skills and knowledge to effectively contribute to their communities. Having aspects of this training as a residential away from home enables an intensive and focussed programme where they will have the opportunity to practice the skills and knowledge over an extended period of time, rather than short workshops of a few hours. The intention is to plan this opportunity within the school summer holidays as part of a wider programme of summer holiday provision. This will provide them with opportunities after the residential to then utilise their learning daily throughout the remainder of the holidays by leading activities within the summer programme. The residential will be led by youthwork staff running workshops, young people and staff planning and organising meals and recreation time activities and outsourcing a local company to provide outdoor activities with a teambuilding and leadership focus.

While our learning offer is open to all local young people, we will work with partners in education and social work to reach those most at need.

Youth work embraces diversity, and we will be joined by young people of all characteristics. We have created a safer space for members of the LBTQlplus community and have welcomed in recent years some new Dundonians from across the world.

We aim to remove barriers and currently work with a few young people with additional and complex support needs.

Youth work provision across the Strathmartine area target young people identified as living in a high SIMD area, subject to many barriers to participation such as poverty, food insecurity, substance abuse and poor social mobility.

A number of these young people are looked after or from single parent families

It is recognised that the need for youth work intervention is greatest across the school holidays as the access to daily support/safe spaces and free food which is available during termtime comes to an end.

In recent years, the summer holiday has provided opportunity for enhanced transition programmes for P7s moving on from cluster schools and has allowed the opportunity for those most at risk of being socially isolated to build relationships with peers and youth work staff.

What local consultation has taken place regarding this application?

Consultation takes place across the year with young people to constantly review the wants and needs of the community with all activity evaluated on its impact within the community.

Young people are targeted through outreach in both primary and high schools, engaging with those young people most isolated and disadvantaged. The project will provide a service with no cost to the young person to allow them opportunities to engage with youth work services during the school holiday period. The project will deliver a diversionary programme and increase opportunities for physical and educational activities for young people that is within the West End Local Community Plan 2017 - 2022.

Improve physical, mental and emotional health for children and young people.

Provide holiday provision across the community, targeting children from low Income families.

What evidence do you hold that the local community supports this application?

In last years "what matters to you" forum the work of youth work holiday provision was highlighted as necessity for local families.

The youth work team, in collaboration with "what matters to you" and partners from local schools, hosted a free barbecue for families and young people in Ardler to promote services in the local area and listen to what families would like to see more of.

The summer holiday provision directly tackles the local issues of food insecurity, social isolation, learning loss and other poverty related issues to having children at home for a long period of time.
