Giving back are looking for funding to assist with the Youth Achievement awards. Giving Back works with community members and young people aged 16-25 on our Youth Employment Programme (YEP) and have been funded by Dundee City Council to complete training to provide Youth Achievement Awards for the community. Over and about the saff training and support from Youth Scotland we are seeking funding to enable us pay for the young people to complete the awards. This price includes the cost of quality assurance, the training booklets, process and printing and return of the accreditation certificate for each individual award to the registered group, school or hub. We are also seeking funding to purchase booklets for them to store their awards and an exit event to celebrate the awards given to the young people.

We need to improve life chances for children and families.

How many people will benefit from this project?

Will any specific groups benefit from this project? (male, female, age range or protected characteristic)

At present we have 11 people using the community groups and 5 on the YEP. The purchase of the books will also allow for other community members to get involved before March.

Youth achievement awards can offer substantial benefits to young people, helping them build confidence, develop valuable skills, and feel more connected to their local community.

By working toward an award—whether it recognises volunteering, creative work, leadership, or personal development—they experience a structured pathway that highlights what they can achieve. Being acknowledged publicly for their hard work can be especially powerful, helping them see themselves as capable contributors to their community. In Broughty Ferry, where community events and local initiatives play a central role, this recognition helps young people feel that they truly belong.

Secondly, achievement awards encourage the development of important life and employability skills. Completing award activities often involves teamwork, communication, planning, responsibility, and problem-solving. These experiences can be invaluable when young people apply for college, apprenticeships, or part-time jobs. Many employers in the Dundee area, including those in hospitality, tourism, retail, and growing sectors like digital media, value young applicants who can show initiative and commitment. Participation in award schemes becomes a practical way for young people to strengthen their CVs and gain a competitive edge plus adding to their SQA points for further education.

Another major benefit is the promotion of positive engagement and motivation. Awards provide structured goals, which can help young people stay focused and purposeful, especially during periods of transition such as early secondary school or the shift to further education. This motivation can be particularly meaningful for young people who struggle with confidence in traditional academic settings. Achievement awards recognise a wider range of

talents—not just exam performance—which helps young people feel valued for their unique strengths.

Youth achievement awards also encourage active citizenship and community involvement. Broughty Ferry has a vibrant community life, from local sports clubs and environmental groups to charity shops and cultural events. Awards that include volunteering or community service naturally encourage young people to participate in these activities. This fosters a sense of social responsibility and builds connections with older generations and community leaders. As young people contribute through beach clean-ups, fundraising events, or helping in local clubs, they learn the impact they can have on the wellbeing of the community around them.

Finally, these awards can contribute to better wellbeing and resilience. Taking part in meaningful activities, setting goals, and working toward an achievement gives young people a sense of purpose and progress. The support from mentors, youth workers, and peers creates a positive network that builds emotional resilience. For many, the experience of overcoming challenges during the award process helps them handle future difficulties with greater confidence.

Giving Back completed discussions with Dundee City Council regarding the awards as well as young people in the area. Through our community consultations accredited awards, training and employment support was discussed as a need that required further development in the area.

What evidence do you hold that the local community supports this application? (For example, was it proposed by members of a particular group? Does it directly address need identified by community members?)

On the pilot programme of the Youth employability programme the young people had discussed the awards being a key feature that they wished to add to the programme and for the community. Due to funding reasons Dundee City Council has scaled back their award programme and no longer advertise

this service provision, however they fund smaller Charites such as Giving back to provide this service, enabling young people to be able to achieve theirs awards Dundee city council has chosen Giving Back to provide this service in Dundee and we are looking for funding to now financially support the accreditation of the awards.

How will the project / activity tackle deprivation or benefit those experiencing deprivation? (Refer to Section 1 of the Guidance Notes)

Youth achievement awards can significantly benefit young people experiencing deprivation by addressing many of the barriers that limit their opportunities, confidence, and long-term prospects. While these awards cannot solve deprivation alone, they offer practical support that helps young people build resilience, develop skills, and access new pathways for success.

A major benefit is the development of confidence and self-belief. Young people from deprived backgrounds often struggle with low self-esteem or the belief that success is out of reach. Achievement awards provide structured goals and the chance to experience success in manageable steps. Being recognised for their efforts—whether through certificates, events, or praise from youth workers—helps them build a stronger sense of pride and motivation. This shift in mindset can make a lasting difference in how they approach challenges.

Youth achievement awards also help young people develop valuable life and employability skills that deprivation can limit access to. Skills such as teamwork, leadership, communication, planning, and problem-solving are built naturally through award activities. These are exactly the skills employers and colleges look for. For young people who may not have access to clubs, sports, or enrichment activities, awards provide an accessible and supportive way to gain experiences that strengthen their future opportunities.

Another important benefit is that awards offer structure, purpose, and positive engagement. Young people facing deprivation may experience instability or a lack of meaningful activities outside school. Award programmes give them something positive to work toward, reducing boredom, isolation, and the risks

that come from having little purposeful engagement. This helps keep them connected to supportive environments and away from negative influences.

Youth achievement awards also increase access to supportive adult relationships. Many deprived young people lack consistent role models. Through award programmes, they receive guidance and encouragement from youth workers, volunteers, and mentors. These relationships help them feel valued and supported, offering a stable source of advice during difficult times.

Another benefit is greater community connection. Deprivation can create feelings of disconnection or exclusion. Award activities such as volunteering or community projects help young people build pride in their area and feel part of something meaningful. This improves wellbeing and strengthens social belonging.
