Please give a description of what you want this grant for - (please limit your answer to 500 words or less)

We would like the grant to cover the cost of hall hire for the full 44 weeks which will be 132 hours. Either closer to Christmas time or another relevant holiday period we may have a one-off whole day celebration depending on youth consultation and what the kids would like and when they would like it. Therefore, have still included the 6 hours of hall hire during the holiday period.

This grant would also cover some of the staff cost, new resources/digital to buy further games suggested by the young people.

We will be putting in a further grant application later in the year for further activity resources and some remainder staff costs. This will depend on the consultation that takes place during these youth club sessions. This Youth club is for the young people, the young people should be able to decide what they prefer to do instead of us just setting up the activities for them.

The resources that are on this grant form have been put forward by the young people themselves.

These activities will be provided after school on a weekly basis and will continue during holidays.

The Youth club sessions will include gaming sessions plus will also have other activities, as an example board games/art and craft – some indoor physical activities. All appropriate consent and parental consent will be received.

At gaming sessions the kids will be playing games such as fortnite, Forza which are very popular games amongst the kids. They will be playing using games consoles connected to TV's. Also, competitions will be held to find the Forza championship racer or a fortnite champion or similar. Young people would also be using Virtual Reality Equipment – to experience places that they have never visited as cannot afford to visit, for some it will be a social meet up experience through the Virtual Reality equipment as some of the young people attending have very low confidence.

In addition to providing clubs for the young people, the equipment can be taken along to other community groups in the area for the users to take part in such experiences that they would never be able to do so. This could be due to having limited social skills, low confidence or cost of living.

The project seems very popular amongst the young people as we have provided over 12 hours of the youth club in the month of March 2024. Positive feedback has been received by parents as well as the young people. This will be further explained in the report due in Apr 2024.

The young people attending the sessions will all register to attend for it to be better organised and managed. All relevant insurance, health and safety policies will be adhered to.

This particular project will keep the young people engaged while taking part in these sessions – the activities will be something that they enjoy doing. There will also be differentiation at these sessions as other non-digital games can also be provided for the minority who may not engage fully at the start of the clubs.

Volunteers will also be managed using relevant policies and procedures. Young people have had the chance to volunteer and will continue in future for the clubs that they attend with all the relevant training given.

Health and Wellbeing - The young people attending will feel happy and confident while attending the session. They will be socialising with each other and making new friends.

Empowering Communities – Young people taking part in these activities will take pride in their own area and will feel confident to lead and set up further activities. They will feel they have been listened to, to have the gaming activities and other activities that they wish for provided in the area.

Cost of Living – These sessions will be provided free of charge for the young people. These sessions will provide experience that they may not be able to gain in real life ...i.e being abroad on holiday. Plus the space is warn for the children to come into while attending the youth club plus there is a snack provided free of charge.

Children and families – Activities provided for the young people. Some sessions can be opened to younger children with age-appropriate games.

We need a community facility in The Ferry – There is no dedicated community centre or youth club where the children and families can drop into and just relax or have others to socialise with. By providing this on a weekly basis – the young people will feel there is a safe place that they can go to which is indoors and feel they belong there.

We need opportunities to get involved in community life in The Ferry – This will give the young people a chance to be involved. As we have just put the application in for the funding, therefore while we wait on the decision for funding, we will keep the young people engaged by going into the local High School for consultations and regular meet ups. Our first meeting is arranged after the Easter holidays. We do not want the young people to be disheartened thinking nothing came out of the previous youth club sessions, and they are no more. Therefore, will keep them engaged by keeping in touch with them.

It has been highlighted the lack of activities for the young people to take part in. Broughty Ferry does not have any community facilities where young people can go to socialise with others.

Feedback from parents and community groups have all mentioned the same and highlighted the lack of activities in the area. There has been an increase in antisocial behaviour in the area which has been highlighted by the Emergency services working in the area and other multi agency/community groups.

Several meetings had taken place during the collective sessions before the Dundee local plan was decided and having lack of facilities in the Ferry was the main discussion in those sessions.

There is local deprivation in the area, families struggle to put their children into clubs or to purchase any digital gaming equipment. This gaming club would give these young people an opportunity to come and take part in and experience this in the gaming club.

Any local meeting with businesses and many other group organisations including the Parent Council at the High School has always mentioned lack of activities for the young people and the rise of anti-social behaviour. Many anti-social behaviour incidents involving the youth have taken place over the last couple of years.

The sessions provided in March 2024 were very popular with attendance rates very high, this just shows the need for something like this in the Ferry ward. Also emails and positive words of encouragement and heartfelt thanks received from other community organisation leaders to us for providing the sessions in March 2024 just shows the need for these sessions. Feedback from parents state what a great idea this is, an example of feedback ' this will get my child out of his shell, he never goes out, does not mix with others' 'He has really enjoyed coming to the club and is buzzing about the club'.

What local consultation has taken place regarding this application? (Please attach evidence summarising the results of any consultation)

The registration numbers for the Youth Club highlights the lack of activities available.

There have been surveys completed where the lack of activities for young people have been highlighted. Same has been highlighted at any information sessions held for the young people or at other meetings such as Broughty Ferry Community Council where young people have been mentioned.

Survey regarding this particular project has also been distributed and the results show the youth want this project to go ahead and are very supportive of this. Feedback from young people at the gaming session provided in March 2024 all has been positive and youth want this project to be continued.

We have spoken to community workers in the area and have had positive feedback where this project can be seen to be very popular with young people. Consultation/discussion has also taken place with the hall organiser and again met with positive feedback for the project. Hall Community leaders are very keen for this project to continue as this just gives the young people a safe place to be inside instead of hanging outside with nowhere to go.

Feedback from local businesses and other local community groups also think these sessions will have a positive outcome as will be great news for the young people.

This youth club can grow into what the young people and the community would like to see added further into the sessions. There has been a steering group set up involving the young people and local stakeholders to steer and lead the club into the direction of success and achievement for the young people.

We have also engaged with Youth Scotland for support and are also waiting to hear from Dundee City Councils Youth Worker lead to discuss the best ways for support to make this a great success and grow into a great project for the young people to take pride in. We are also looking to engage with Universities where the students can come and explore the 3D printing with young people, young people are very excited re this as at the end of the session they will get a physical item to take home and can show their work as a piece of art and be very proud.

What evidence do you hold that the local community supports this application? (For example, was it proposed by members of a particular group? Does it directly address need identified by community members?)

Young people and parents at school support this idea. Local businesses and community groups also support this idea as this idea has been discussed with the community at various different meetings. An informal discussion has also taken place with the local community officers where the idea was discussed. This has been mentioned above in the consultation part. As evidence we hold survey results – Observation notes– minutes from various meetings attended, text messages, verbal consultation notes, email messages. Also comments on the local Ferry facebook pages can be read about the youth cub.

We have had support from Mens Shed Broughty Ferry to help us set up by building the previous equipment purchased.

virtual meeting was held with local church youth worker, who also stated this is a brilliant idea as she finds it very difficult to engage the children as the group at the church is seen as a church group and not a youth club. Very few children attend as find this not cool as it is run by the church. Having upto date digital equipment and outwith the church will encourage the children to attend. Plus this group will be run by the steering group of young people themselves with ideas and suggestions.

The project activities will be provided free of charge to young people. In addition to this any future competitions to be held can also be provided free of charge who stay in areas of deprivation. The young people will also be able to enhance their volunteering skills through the opportunity to volunteer at the gaming club. Volunteer opportunities can also be offered to less advantaged young people.

The young people who do not have the experience of going away on a holiday due to cost will be able to experience this using Virtual Reality Equipment (VR). Through the VR, young people will be able to choose a country where they would like to go on holiday and experience being there. This will make them happy and will feel confident. The equipment can also be used to take part in job experiences, which will enable the young person to feel confident and work towards gaining that particular career route which in return will gain employment.

Young people will also be able to enjoy some refreshments and be warm while at the club. This space will be used as a warm space as the heating will be on. We have also added 2 fan heaters on the application as sometimes the hall may seem a little less warm, therefore heaters can be used. Budgeting sessions can be provided as part of the youth club, which will increase confidence and also learn more about looking after money, spending wisely etc.

The Ferry is seen to be an affluent area, people think that there is no poverty in this area. This is not true as this is evident by the number of people using the free school uniform shop and the food larder in the local schools.

These sessions are provided free of charge to all – there is no financial barrier to participation in the youth club. Therefore closing the gap between the disadvantaged young people and others. The barrier of socially isolated young people maybe a barrier for some young people, we will work closely with the local high school to target these young people without them being aware of any particular targeted work as others will also be in the same group offered the same sessions. We have already identified some young people who face these barriers using consultation groups and also parents sharing this information in confidence.

As evidence we hold survey results – Observation notes– minutes from various meetings attended, text messages, verbal consultation notes, email messages. Also comments on the local Ferry facebook pages can be read about the youth cub.

We have had support from Mens Shed Broughty Ferry to help us set up by building the previous equipment purchased.

virtual meeting was held with local church youth worker, who also stated this is a brilliant idea as she finds it very difficult to engage the children as the group at the church is seen as a church group and not a youth club. Very few children attend as find this not cool as it is run by the church. Having upto date digital equipment and outwith the church will encourage the children to attend. Plus this group will be run by the steering group of young people themselves with ideas and suggestions.

The project activities will be provided free of charge to young people. In addition to this any future competitions to be held can also be provided free of charge who stay in areas of deprivation. The young people will also be able to enhance their volunteering skills through the opportunity to volunteer at the gaming club. Volunteer opportunities can also be offered to less advantaged young people.

The young people who do not have the experience of going away on a holiday due to cost will be able to experience this using Virtual Reality Equipment (VR). Through the VR, young people will be able to choose a country where they would like to go on holiday and experience being there. This will make them happy and will feel confident. The equipment can also be used to take part in job experiences, which will enable the young person to feel confident and work towards gaining that particular career route which in return will gain employment.

Young people will also be able to enjoy some refreshments and be warm while at the club. This space will be used as a warm space as the heating will be on. We have also added 2 fan heaters on the application as sometimes the hall may seem a little less warm, therefore heaters can be used. Budgeting sessions can be provided as part of the youth club, which will increase confidence and also learn more about looking after money, spending wisely etc.

The Ferry is seen to be an affluent area, people think that there is no poverty in this area. This is not true as this is evident by the number of people using the free school uniform shop and the food larder in the local schools.

These sessions are provided free of charge to all – there is no financial barrier to participation in the youth club. Therefore closing the gap between the disadvantaged young people and others. The barrier of socially isolated young people maybe a barrier for some young people, we will work closely with the local high school to target these young people without them being aware of any particular targeted work as others will also be in the same group offered the same sessions. We have already identified some young people who face these barriers using consultation groups and also parents sharing this information in confidence.
